Mallya and his legal team have not made a renewed commitment in relation to the appeal but soon after the UK home secretary had signed off on the Westminster Magistrates' Court order in favour of extradition on February 4, the businessman had taken to social media to confirm his plans to seek an appeal.

"After the decision was handed down on December 10, 2018 by the Westminster Magistrates' Court, I stated my intention to appeal. I could not initiate the appeal process before a decision by the Home Secretary. Now I will initiate the appeal process," he said in a Twitter statement earlier this month.

The former boss of the now-defunct Kingfisher Airlines took to Twitter again this week to call on Prime Minister Modi to accept his settlement offer in relation to the airline's loan default. —PTI
